





2. The institution is irrevocable.
3. The activities would be confined to the territory of India.
4. The funds of the institution would be utilized only towards the objects and no portion of it would be distributed in any manner to the trustees or persons defined in section 13(1) (c) of the Income Tax Act, 1961.
5. Not more than 5% of the Income of the trust/ institution would be applied for any religious purposes or given to religious institutions. (Any violation found will lead to denial of exemption under sec 80G considering the Trust as Public Religious in nature);
6. The Founder Trustee shall be empowered to co-opt additional Trustees to form committees as and when required.
7. There are no properties movable / immovable in the name of the Trust. Only Corpus fund of Rs.3,000/- is in the name of the Trust as on date.



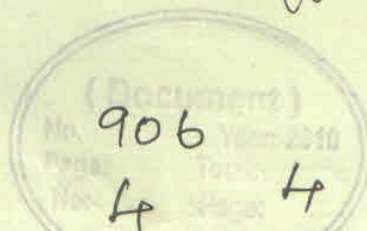
